

Colored Pencil Pals – Virtual Studio

One good aspect of the virus situation is the creation of the “Colored Pencil Pals”. This has turned out to be a great success. This is a virtual studio where colored pencil artists meet for a few hours every Tuesday. This gives us the opportunity to meet in a safe, virtual environment. We share ideas, perhaps talk about new books or products we are using. It also provides a time to get helpful insight from other artists on our individual artworks. Additionally, a weekly challenge was developed to get those creative juices flowing. These are not huge masterpieces, but usually modest sketches, or even artist trading card size, (2 1/2 by 3 1/2 inches.)

Studio time is from 11:00 until 2:00 every Tuesday. You are welcome to drop in anytime just to say “Hi!” Stay for a few minutes or stay for the entire session. 
Annual Holiday Meeting



Member Product Review

Rembrandt Lyra Polycolor Colored Pencils

The Rembrandt Lyra Polycolor Pencils - my experience with an oil based colored pencil. I purchased a 72 color set of Lyra Polycolor pencils and put them to the test on a small, 8x10 work on Stonehenge paper. The result was my entry into the most recent Chapter 119 Exhibition, titled "Buttercup." I had zoomed my camera lens on the tiny flower that is so prevalent in fields and in the woods where I walk. I decided to put it into a dramatic black background.



I hoped that using mineral spirits to blend would be smoother since Polycolors are oil based. The pencil lead is harder than I expected. The application is very smooth and almost velvety. The mineral spirits did not affect the pigment any more than it would a Prismacolor pencil which is wax based. I was hoping for a color intensity like that of an Intense* pencil with the application of water, but it is nothing like that. So I just applied the color in linear strokes, like I usually do. The application was smooth. The coverage was much easier and left no bloom, except for the black background. That was splotchy with the addition of mineral spirits and I applied several layers of color into that black and then it did develop a bloom - but only in that area.

I am used to instinctively reaching for a color at the opposite side of the color wheel to make a duller or richer color. That did not work so easily with the Lyras, even with a set of 72 pencils. One or two layers of different colors seemed to be all that could be applied, and the last color applied was the visible color, rather than mixing with previous layers. I don't know why; I was surprised that lighter pigments were

more transparent. I guess it is universal that lighter colors carry less pigment and more base.

I had no problems with crooked leads in the the wooden case, the pencils sharpened easily and left a long sharp point. I had no breakage of lead in the sharpener, using my Foray or even my Aformat, giving me a long thin point. I do like the easy smooth application of these pencils and I intend to do more pieces using only these pencils to improve my technique, hoping that some of these issues can be resolved with more experience and knowledge of their properties.

Sandy's art piece called "Buttercup" earned Honorable Mention in our last chapter show.

The little girl (in the portrait) is my granddaughter. As a baby, her nickname was Chickee, so it was most appropriate (as the title of this work). Most people think of the chicken, of course.

I am fortunate in that I have a "light hand" so that I can put several layers of pencil on the paper. I always start with the face. If the face isn't right then there is no need to continue. Once I am satisfied that the face looks like that person then I can proceed with the rest. I always work the background last. That gives me plenty of time to decide how I want the background to look. I wanted everything to focus on her face first then the chicken. I hope it worked.

I have been working in colored pencils for about 3 or 4 years. Before, I had been learning watercolor. Growing up, I worked in charcoal, pastels, and oils. I like colored pencils because of the details that can be accomplished with them. Colored pencils also tap into my patience vault because it can be a slow process.

I guess Prismacolors are my favorite pencils because those are the ones I learned first. I have expanded into F-C Polychromos, Caran D'Ache Luminance and Supracolors, especially if I need a particular color choice. I have been a member of DC 119 for about 3 years.

I love doing portraits, especially of my grandkids. To do a face is the most challenging. (I took a portrait class for a year.) I love the Old Masters. I choose my subject if I can connect with it. The subject evokes a feeling or a memory. I have done several pet portraits on commission.

I was a biology major in college after deciding that I wanted to keep my art as a personal hobby. Studying science had an impact on me as far as attention to detail. That truly helps and carries over into art. My art went to the back burner while I raised my family and did the career thing. I finally had a chance to return to art in 2010. We even built a studio onto our house for me to work in -- now that's dedication! (Or a lot of art supplies....) BTW, the studio also serves as a quilting studio so the space is shared half and half. Either way, I get to work with color.

Prospectus & Entry Rules:

1. Any artists, 18 years or older, working in colored pencil may enter and need not be a member of the CPSA. Works must be original, and 80-100% colored pencil, according to CPSA International or Explore This! guidelines.
2. Up to three pieces may be submitted per entry fee.
3. Entry fees are \$30.00 for CPSA members, and \$40.00 for non-members. Fee is due with entry submission.
4. Deadline to submit entry application is Monday, January 4th, Check payable to: **CPSA DC 119**
5. Artwork must be framed, ready to hang and utilize wire for hanging. No saw-toothed hangers permitted.
6. Each piece must have an identification label attached to the back in the upper right hand corner. (see reverse)
7. All art work sold will be charged a 20% commission.
8. Entries must have been completed after 2018. Concept of design and execution of artwork must be solely that of the artist, completely original, no reproductions.
9. Award winning pieces from previous DC119 shows are not acceptable. Work that was entered in last year's show, but did not win an award, can be entered again in this show.
10. Artist grants permission to DC119 and CPSA to reproduce entries for publicity purposes.
11. Works are not insured. Neither CPSA DC119 nor the Venue will be held responsible for theft or liable for any damages.
